Day Camp Code of Conduct

Camp Rules:

- NO ELECTRONICS. (Electronics include: Cell phones, Game Boys, iPod's, iPad's and tablets, etc.) This includes: bus rides, Wednesday trips, the beach, etc. Phones must remain in backpacks and can be used by permission only. We are not responsible for lost or stolen items.
- Respect yourself and others and use appropriate language at all times
- Practice good sportsmanship
- Keep hands and feet to yourself.
- Let staff know where you are at all times, if you can't see a counselor, you are too far away.
- Observe bus safety rules. Follow directions given by the bus driver.
- No sharing food.
- Camp shirts are given to new campers on Tuesdays; Camp shirts must be worn on all Wednesday (and some Friday) trips. **You will be charged \$20 for any additional shirts.**

Beach Rules:

- **YOU MUST BE WITH YOUR BUDDY AT ALL TIMES!**
- Be respectful of other people at the beach.
- No horseplay in the changing room.
- When in the water, stay between the cones on the beach.
- Campers are not allowed to be in water above their armpits, unless with a counselor.
- If your buddy does not want to be in the water, they must be on the beach and the swimmer cannot go above their belly button.
- No dunking in the water.
- You must have a counselor and a buddy with you to use the facilities.
- Campers must stay within the boundaries of the NRD Day Camp and cannot leave to be with another family or group.
- Campers are responsible for their own money. We recommend that all cash be placed in a wallet or a secure bag with your name on it.
- Each beach has their own set of rules, please be aware that there may be additional restrictions depending on the location.

Camper Consequences:

- **First Incident**-Camper will receive a verbal warning and may be asked to sit out of activity
- **Second Incident**-A phone call will be made to parents and/or guardians on the day of the incident, followed by a letter home
- **Third Incident**-Meeting with Camper, parents and/or guardians, and day camp staff to discuss behaviors and possible solutions
- **Fourth Incident**- Camper will no longer be able to participate in NRD Day Camp
